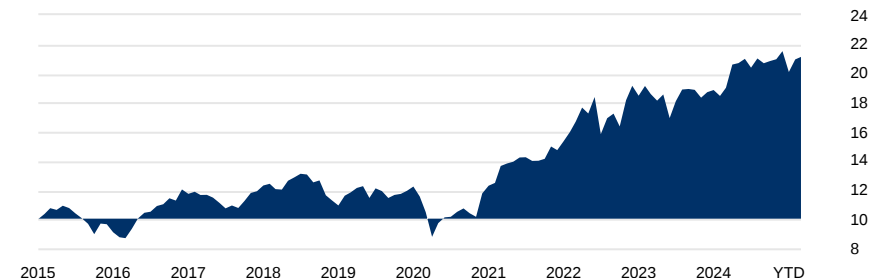

100% Market Cap weighted blend of MSCI World Energy Total Return Net Index (CAD) and MSCI World Materials Total Return Net Index (CAD)

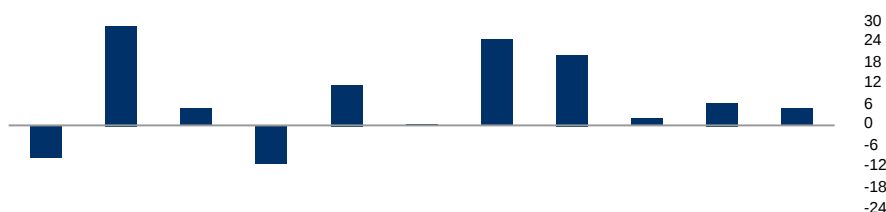
Performance analysis for Series D as of February 28, 2025

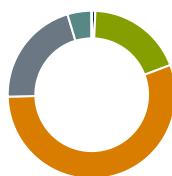
